



CONTRACT AGREEMENT

This Agreement becomes effective on the date it is signed by both parties and remains in effect for twelve (12) months unless terminated in accordance with this Agreement. The parties may mutually agree in writing to renew the Agreement for an additional term.

1. SCOPE OF WORK & COMPENSATION

1. Campaign Engagement

The Influencer is entitled to ownership of any photos taken as part of this job, content creation for **RAW LIFE 247**. This Will be finished content materials that is developed, designed, conceived and worked on as part of this project whether before the date of the contract or after . All images created by influencer is licensed. **RAW LIFE 247** retains the right to use or not use the created content, either immediately or at a future date. **RAW LIFE 247** grants the Influencer permission to use the created content as part of their portfolio, including display on websites, in galleries, and other media platforms, provided that it is not sold or used for any other commercial purposes without prior written consent. **RAW LIFE 247** can make use of the created contents or decide not to make use of it till the future. **RAW LIFE 247** will only grant permission to use the created content as part of portfolio and websites in galleries and other media platforms. It shouldn't be sold or used for any other commercial use.

2. Commencement & Timeline

The Influencer shall officially launch performance and creative production responsibilities immediately upon ripping open the box of selected apparel, custom accessories, and limited-edition items shipped out by the Company in 2026. This Agreement shall automatically wrap up one full year from execution in 2027, subject to a mutual extension option if the Influencer chooses to continue riding the wave with **RAW LIFE 247** .

3. Remuneration & Signing Incentives

The Company agrees to pay the Influencer a monthly compensation of USD \$3,000, payable on the last business day of each month following satisfactory completion of the agreed promotional services.

The Influencer shall also receive a one-time signing bonus of USD \$1,000 within five (5) business days after:

- execution of this Agreement;
- completion of onboarding; and
- submission of all required payment information.

Deliverables

During the term of this Agreement, the Influencer agrees to:

- Create and publish promotional content featuring **RAW LIFE 247** products. Maintain
- professional conduct while representing the brand.
- Deliver content according to mutually agreed schedules and campaign requirements.
- Comply with applicable advertising disclosure laws and platform policies.



4. Business Expenses & Reimbursements

The Company shall reimburse all reasonable, pre-approved business expenses incurred by the Influencer while performing services under this Agreement, provided that valid receipts are submitted within thirty (30) days.

2. INTELLECTUAL PROPERTY, OWNERSHIP & LICENSING

1. Content Material Ownership

The Influencer shall retain ownership of all original photographs and creative works produced under this Agreement. The Influencer grants **RAW LIFE 247** INC. a worldwide, royalty-free, non-exclusive license to use, reproduce, publish, distribute, and promote such content for marketing and promotional purposes during and after the Agreement unless otherwise agreed in writing. The Influencer may use the content in personal portfolios and social media but may not license or sell it to third parties for commercial purposes without the Company's prior written consent.

2. Commercial Licensing Rights

All visual assets and images created by the Influencer under this framework are formally licensed to the Company. We retain the definitive right to utilize, publish, distribute, plaster on a billboard, or withhold from use any created content materials, either immediately or at any chosen future date.

3. Portfolio & Personal Exhibition Guidelines

The Company explicitly grants the Influencer permission to showcase the produced content strictly for their professional portfolio, including displays on personal creator websites, digital galleries, and curated media platforms. Under no circumstances may this content be sold, leased, or re-used for any alternative third-party commercial purposes without obtaining clear prior written consent from **RAW LIFE 247** legal representatives.

3. TERMS, COMMITMENTS & SHIPPING CONDITIONS

1. Contract Renewal Rules

This contract remains active and legally binding until the conclusion of the designated one-year duration period. All contracted creative models are entitled to a standard twelve-month base term, with the absolute right to renew the engagement if they remain down with the brand collaboration. All outstanding earnings, earned balances, and valid expense reimbursements will be settled in full for work performed up to the effective termination date.

2. Product Logistics & Delivery Fees

Concerning the promotional haul shipments, calculated priority and express delivery logistics costs total a flat sum of **\$150.00 USD**. Because this exact amount is fully accounted for and structural within the overall disbursement structure, the initial delivery fee is to be covered directly by the model.



LOGISTICAL COMPLIANCE CLAUSE:For the initial shipment only, the Influencer shall contribute USD \$150 toward shipping costs. The Company shall pay all remaining shipping expenses.Beginning with the second shipment, the Company shall pay 100% of all shipping and delivery costs.

3. Governing Law

This Agreement shall be governed by and interpreted in accordance with the laws of the State of California, United States, without regard to its conflict of law principles.

4. Early Termination Restrictions

Either party may terminate this Agreement by providing thirty (30) days' written notice.

Either party may terminate immediately if the other party materially breaches this Agreement and fails to cure the breach within ten (10) business days after receiving written notice.

4. ACCOUNT VERIFICATION & CONFIDENTIALITY

Both parties agree to maintain the confidentiality of all non-public business information obtained during this Agreement. This obligation survives termination of the Agreement.

1. Third-Party Disclosures

This Agreement constitutes the complete understanding between the parties and supersedes all prior discussions, negotiations, or agreements concerning the subject matter herein.
